NOTES TO FINANCIAL RESULTS:

1. The above unaudited financial results as reviewed by Audit Committee have been approved at the meeting of the Board of Directors held on 31st July, 2019. Limited review of the above results have been carried out by the Statutory Auditors of the Company.

2. The consolidated results include the result of the company's associate Meghalaya Power Limited (MPL) in which the Company holds 48.80%

3. The Company has adopted Ind AS 116 'Leases' with effect from April 1, 2019, as notified by the Ministry of Corporate Affairs (MCA) in the Companies (Indian Accounting Standard) Amendment Rules, 2019 using modified retrospective method. Accordingly, the comparatives have not been retrospectively adjusted. The adoption of this standard did not have any material impact on the profit of the current quarter.

4. The figures for the quarter ended 31 March 2019 are the balancing figures between addited figures for the year ended 31 March 2019 and unaudited figures for the nine months ended 31 December 2018.

5. There were no exceptional item during the quarter ended 30th June, 2019.

6. Figures of the previous period have been regrouped and reclassified to confirm to the classification of current period, wherever necessary.
